In 2022, we celebrated 10 years of advocacy for child victims of abuse in our community! As I reflect on those last 10 years, I am reminded of all the remarkable accomplishments. We have seen unprecedented growth of the organization's programs, facilities, staff, and revenue. We have been fortified by remarkable levels of community support and recognition for the importance of our role in the investigation of child abuse cases, family advocacy support services, and our mental health programming. We are so grateful to all of you for your commitment to creating a safer world for children.

A total of 304 children walked through our doors last year. Those children are seen by our Multidisciplinary Team for concerns of child abuse and come to us seeking hope and healing. We also reached 5,218 people in our community through our prevention education programs. Our reach has grown astronomically as we have fully embraced our mission to intervene and prevent child abuse. We are deeply proud not only to have provided the best quality, nationally recognized investigatory services for these children; evidence-based trauma responsive mental health services to hundreds of those children; and to have partnered with so many wonderful organizations, churches, schools, and individuals to provide prevention services to children, adolescents, and adults this past year. This is truly a testament to our exceptional staff and partners, made possible by the support of a generous and compassionate community.



We have made significant strides in all five areas of our strategic priorities, and as a result we believe the children of Chilton, Autauga, and Elmore Counties are safer and better informed about interpersonal dangers to themselves and their peers.





# 6,110 SERVICES PROVIDED

Every day children victimized by abuse come to Butterfly Bridge Children's Advocacy Center where they find caring professionals and community partners who dedicate themselves to helping them through the nightmare of abuse and neglect. The Center provides a friendly environment where children can safely tell their story and receive the support they need. Within the Center, families find support, resources, and most importantly a place where healing begins.



# 315 FORENSIC INTERVIEWS

Specially trained staff members at BBCAC conduct legally justifiable fact finding interviews with children at the request of law enforcement or the Department of Human Resources during child abuse investigations. The interviews are designed to allow a child to disclose abuse if abuse has occurred.



2,487 ADVOCACY

Advocacy is designed to provide a continuum of care for children and families throughout the criminal justice process. We working closely with the local multi-disciplinary team of professionals who investigate cases. We also provide support through the process to make sure no clients' needs go unmet.



2,016 THERAPY

Evidence based, trauma informed interventions allows child victims and their non-offending family members the chance to heal from abuse. Services include: therapeutic services for child abuse victims, psychoeducational support groups for non-offending family members, and referrals to other needed community resources.



#### 30 MDT MEETINGS/CASES REVIEWED

BBCAC coordinates intervention among child welfare professionals in Chilton, Autauga, and Elmore counties to ensure protection of victims and their non-offending family members. Communication across agencies strengthens criminal cases so that perpetrators can be held accountable, keeping our community safe.


