Then in the summer of 2021, we were thrilled to kick-off our Capital Campaign in Chilton County and renovations began on our new, forever home which will help us meet the needs of the most vulnerable now and years into the future. Within a few months, the Capital Campaign was fully funded thanks to generous donors and our Clanton office moved in late 2021.

Throughout this past year we have remained committed to ensuring that all client services and projects continued in a safe manner so we could continue to meet the critical needs of children and families victimized by child abuse. This next year is one of change and rapid growth, and we are excited to be celebrating our monumental 10th anniversary in 2022. 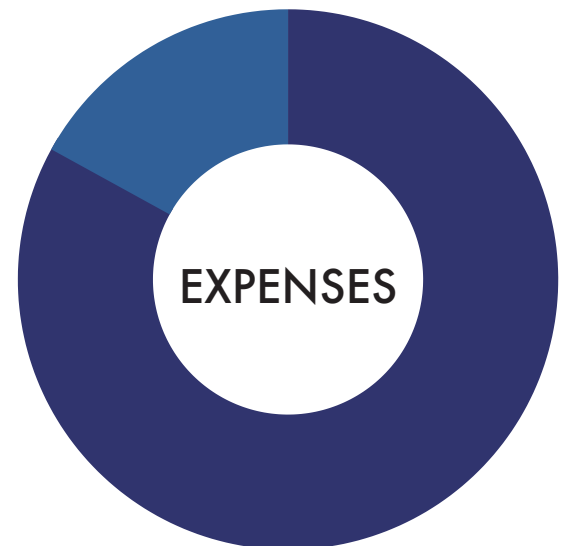

Specially trained staff members at BBCAC conduct legally justifiable fact-finding interviews with children at the request of law enforcement or the Department of Human Resources during child abuse investigations. The interviews are designed to allow a child to disclose abuse if abuse has occurred.

**397** FORENSIC INTERVIEWS



Evidence-based, trauma-informed interventions allows child victims and their non-offending family members the chance to heal from abuse. Services include: therapeutic services for child abuse victims, psycho-educational support groups for non-offending family members, and referrals to other needed community resources.

**2511** THERAPY



Advocacy is designed to provide a continuum of care for children and families throughout the criminal justice process. We working closely with the local multi-disciplinary team of professionals who investigate cases. We also provide support through the process to make sure no clients' needs go unmet.

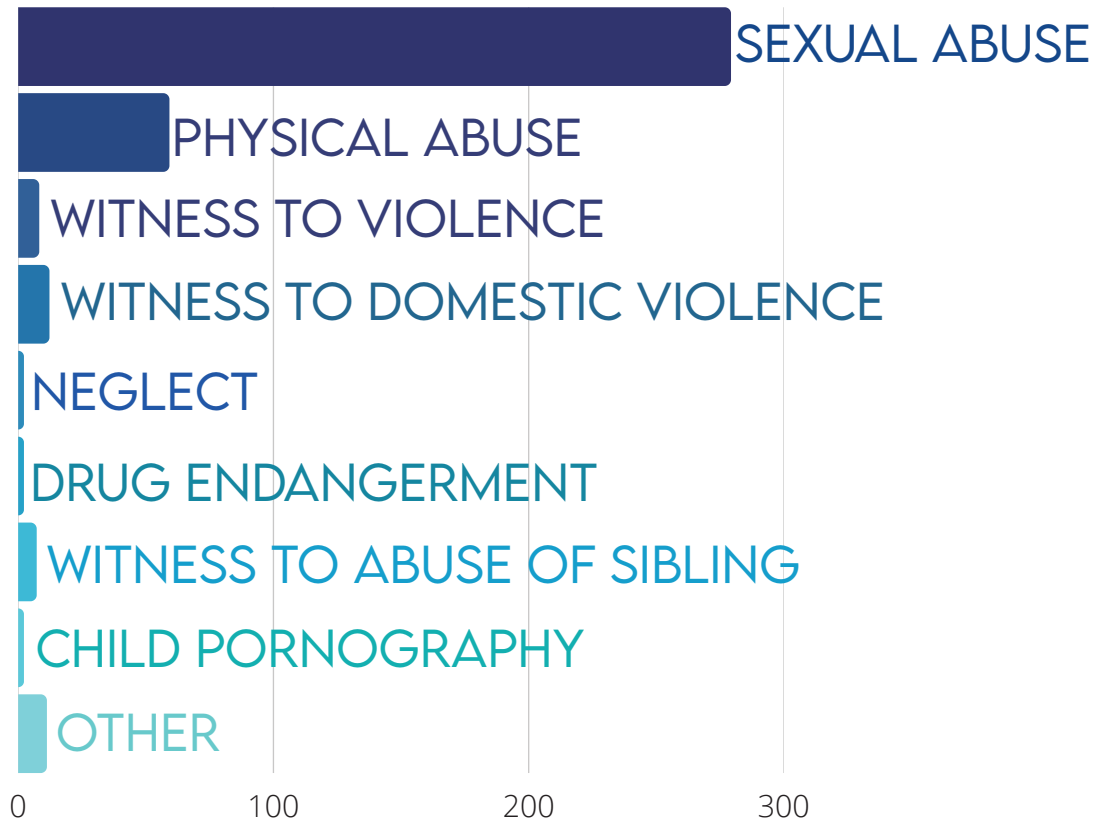

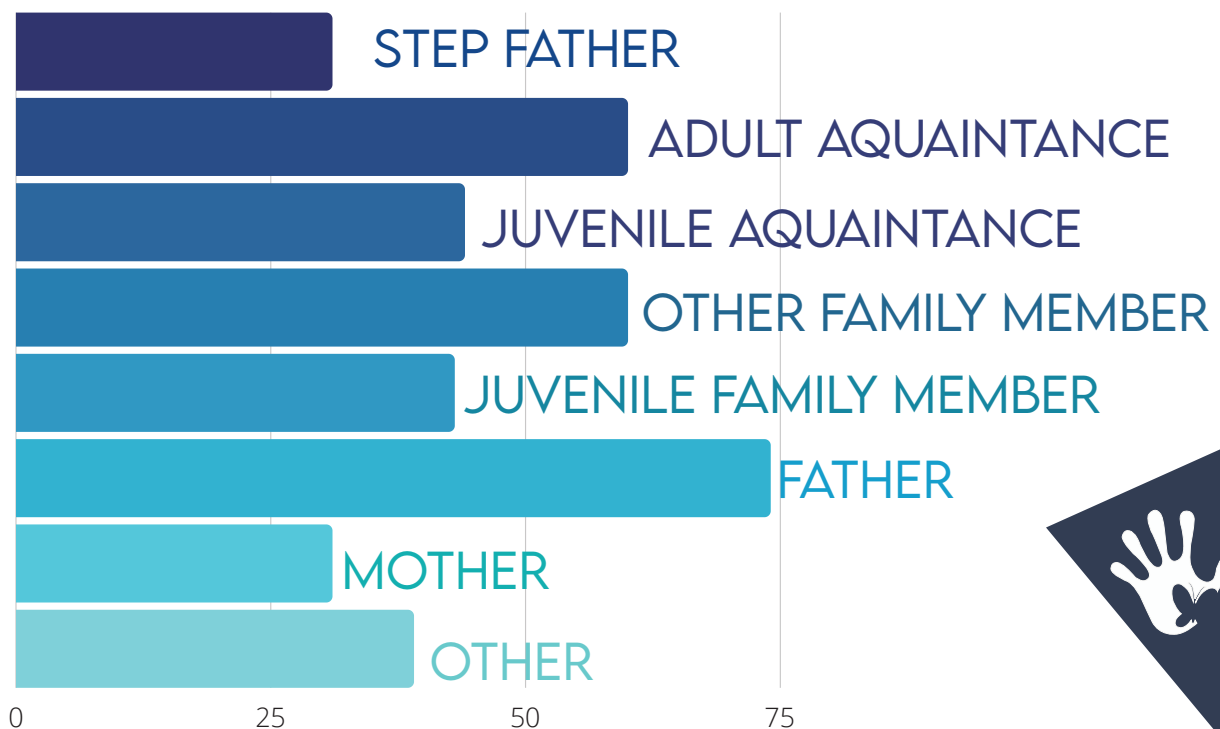
