FROM OUR EXECUTIVE DIRECTOR

Dear friends,

The statistics are unsettling: 1 in 4 girls and 1 in 6 boys will be sexually abused before the age of 18, and only 1 in 10 will tell someone. Last year, there were 401 reports of child abuse and neglect involving 614 children made in Chilton County. Out of those 409, 133 involved allegations of sexual abuse, severe physical abuse, or witness to crime. Those children were served at Butterfly Bridge CAC and many continue to receive services as we speak.

The enormity of the problem can overwhelm us all. It is easy to feel that the problem is so huge and so pervasive that there is little one person can do. The truth is that it is **ONE** person who makes all the difference.

With your help, 2017 was a year of continued growth across all of our programs. We were able to not only serve the children and adolescents who have been victims of abuse, but also extend invaluable services to their non-offending family members as well. We also continued to work closely with the Chilton County Board of Education on implementing Erin's Law. Our focus during the year was to ensure that not only Kindergarten – 5th grade students were being taught abuse prevention in their classrooms, but also 6th – 12th graders were being taught information on peer-to-peer sexual abuse, technology safety, and other pertinent topics affecting youth today in compliance with the law.



While we wish we could protect all children from trauma, in 2017 we continued to see children who had experienced horrific physical and sexual abuse, neglect and/or violence. We are constantly amazed at the resiliency of children who have lived such fractured lives but can still respond to interventions that address their trauma and support a return to a healthy childhood.

We are extremely proud of the quality of services that we provide and thankful we can be right here in our community to provide them! So, to all of you who support Butterfly Bridge CAC's mission, thank you for seeing hope where others see hopelessness, because you give children the gift of childhood.

2017 In Review

We conducted **138** Forensic Interviews with **133** children and adolescents at the request of our local multi-disciplinary team at the onset of child abuse investigations.



552 therapy sessions were provided to children and adolescents to help them heal from the abuse. **48** Caregiver Support Sessions also provided.



We coordinated **12** Multi-disciplinary Team Case Review meetings in which **464** cases were reviewed that are currently under investigation or in the criminal justice system.



907 Advocacy Services were provided which included advocacy at the time of the CAC forensic Interview, extensive follow-up with the families, court preparation, and court accompaniment.

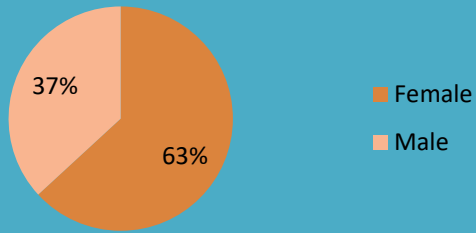

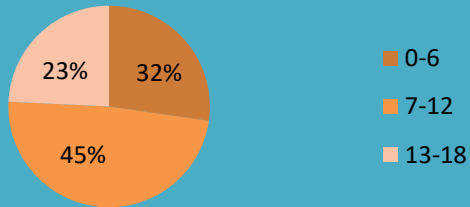

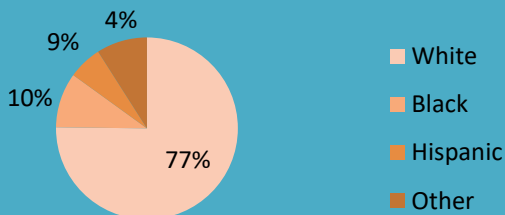

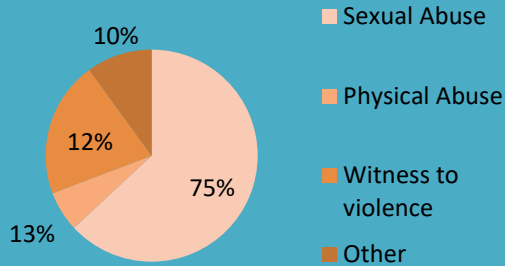

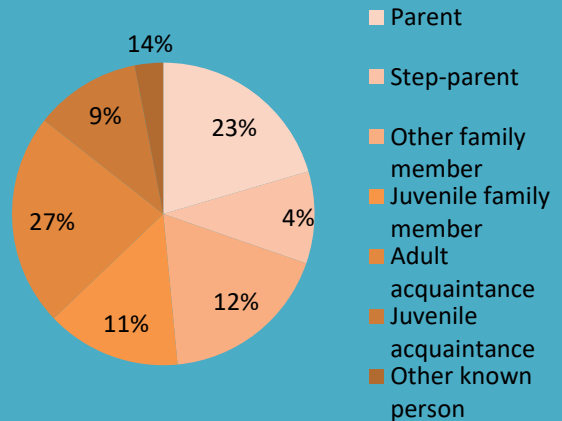

Relationship of Alleged Offender to child

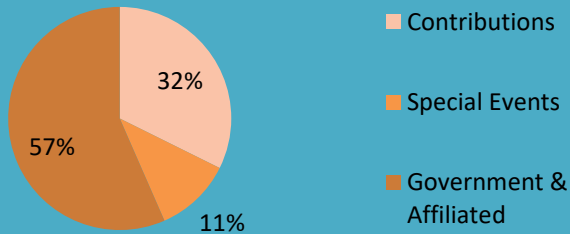

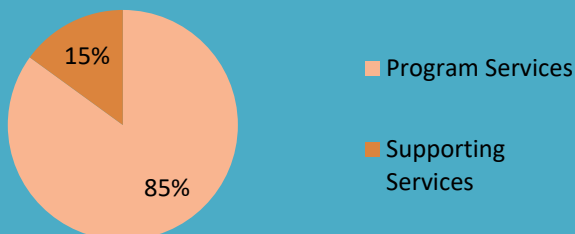
